Beautiful Deer Lake

People often associate lake water quality problems with large-scale agriculture, or forestry, urban development, or industrial practices. But the truth is that **property owner actions have a significant impact on lake water quality**. The impact of land use decisions on one lake lot may be relatively small, yet the cumulative impact of small decisions on many lake lots can result in a significant decline in water quality.

Property owners can help:

- Prevent aquatic invasive animals and plants (AIS) from infesting Deer Lake
- Reduce the amount of phosphorus dumped into Deer Lake
 - Septics
 - Rainwater runoff
 - Shoreline erosion
 - Streams

Phosphorus is a nutrient that causes algae and undesirable weed growth. Deer Lake is highly sensitive to phosphorus loading, meaning that additional phosphorus causes a disproportionate decrease in water quality. The good news is that this sensitivity also means that *if we reduce the amount of phosphorus running into the lake, water quality will increase disproportionately*.

Your individual action could make the difference to Deer Lake.

Not transferable.

____ \$12.50 **Associate Annual Membership:** Any person, family, firm, association, corporation or other legal entity not qualifying for Annual Membership. Associate Annual Members have all the rights of Annual and Lifetime Members except the right to nominate candidates for Board of Directors or officers of DLA, or any vote of the membership unless actively serving as a director at the time vote is taken.
